**SECOND SUPPLEMENTAL  
STIPULATION AND  
ORDER PERMITTING CERTAIN  
INDIVIDUALS TO REVOKE THEIR  
OPT-OUTS AND PARTICIPATE IN  
THE 2.0-LITER AND 3.0-LITER  
CONSUMER CLASS ACTION  
SETTLEMENTS**

1 WHEREAS, on September 22, 2017 and October 25, 2017, the Court issued Orders  
2 allowing certain individuals who had opted out of either the Consumer Class Action Settlement  
3 Agreement and Release (Amended) (the “2.0-liter Settlement”) or the Consumer and Reseller  
4 Dealership 3.0-liter Class Action Settlement Agreement and Release (Amended) (the “3.0-liter  
5 Settlement”) (collectively, the “MDL Settlements”) to revoke their opt-outs from, and participate  
6 in, the MDL Settlements;

7 WHEREAS, certain additional individuals who opted out of the MDL Settlements now  
8 also wish to revoke their opt-outs from, and participate in, the MDL Settlements (the “Additional  
9 Participating Individuals,” listed on Appendix A hereto); and

10 WHEREAS, neither the Volkswagen Group Defendants nor the Plaintiffs’ Steering  
11 Committee (collectively, the “Parties”) object to the Additional Participating Individuals’  
12 revocation of their opt-outs and participation in the MDL Settlements.

13 IT IS THEREFORE STIPULATED AND AGREED, subject to approval of the Court,  
14 that the Additional Participating Individuals’ previous opt-outs from the MDL Settlements are  
15 revoked, and each Additional Participating Individual may participate in the MDL Settlement  
16 from which he or she previously opted out pursuant to the terms set forth in that MDL Settlement.
